### **Resolution #15-15**

-Approve Ron Harter as girls JV basketball coach, effective January 21, 2015. He will be paid, based upon the number of weeks in the season, less 12 weeks, at Step 2B.

-Approve the re-assignment of Marilyn Bohrer to a 5<sup>th</sup>/6<sup>th</sup> grade teacher position in the elementary.

-Approve the resignation of Brian Gerdeman as elementary principal, effective at the end of his current contract. He will be returning to the classroom as a teacher.
